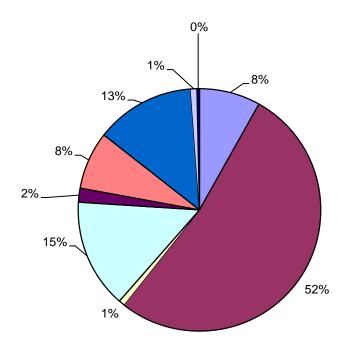

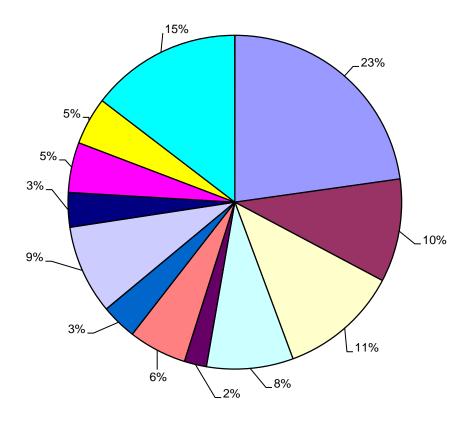

#### 2011 Revenue



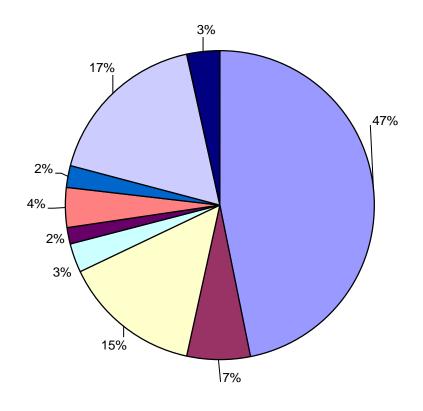

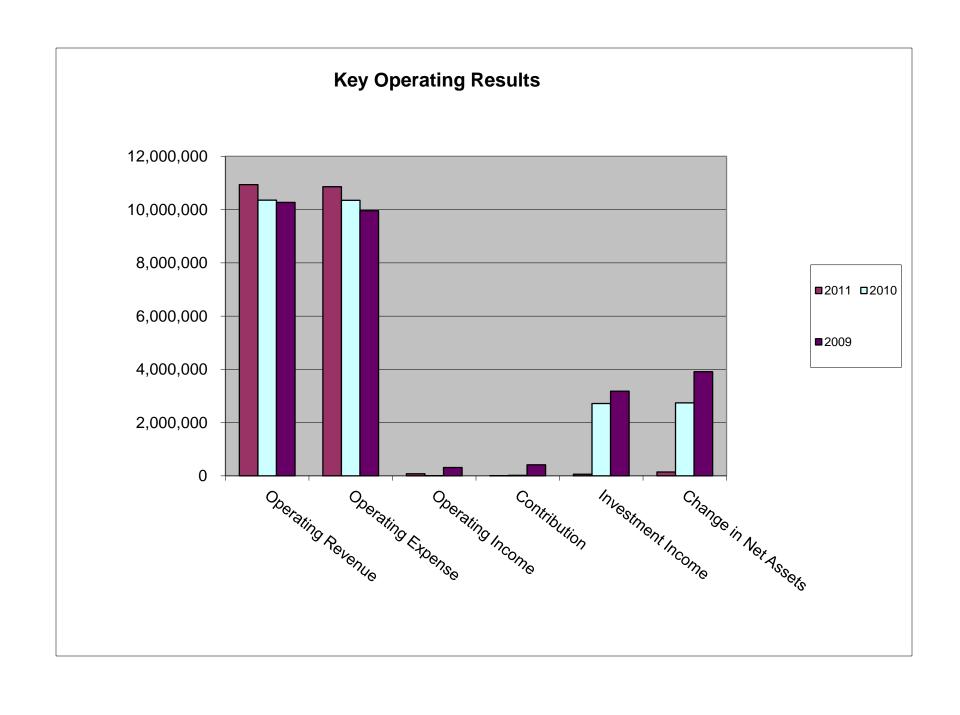
