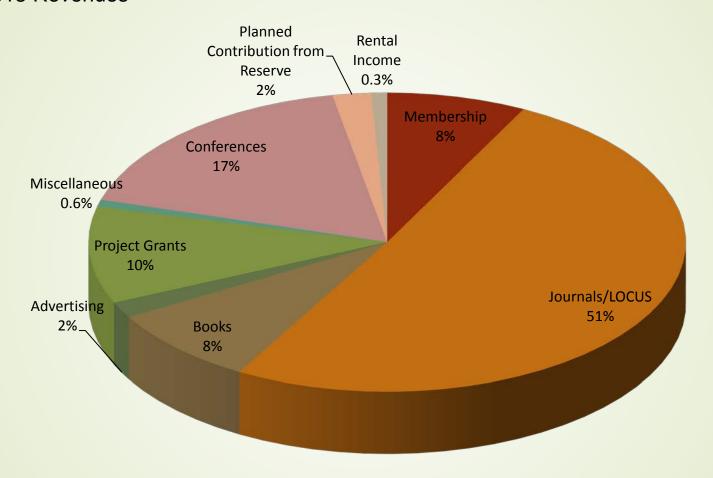

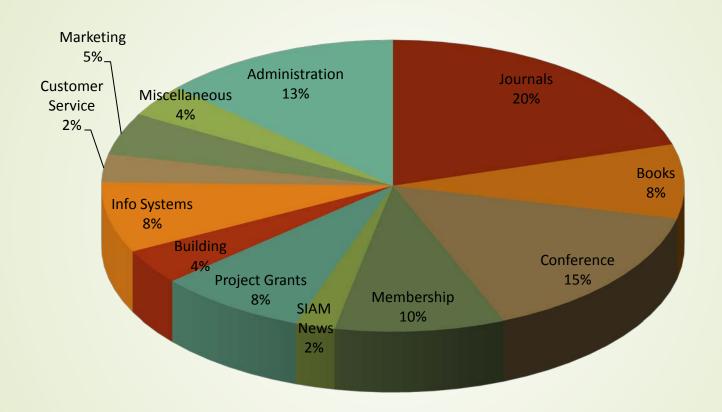

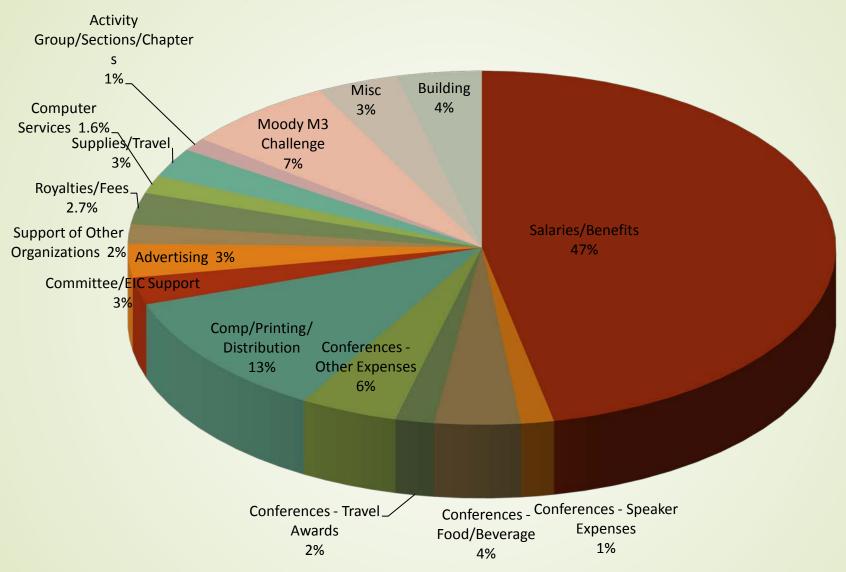
2015 Revenues



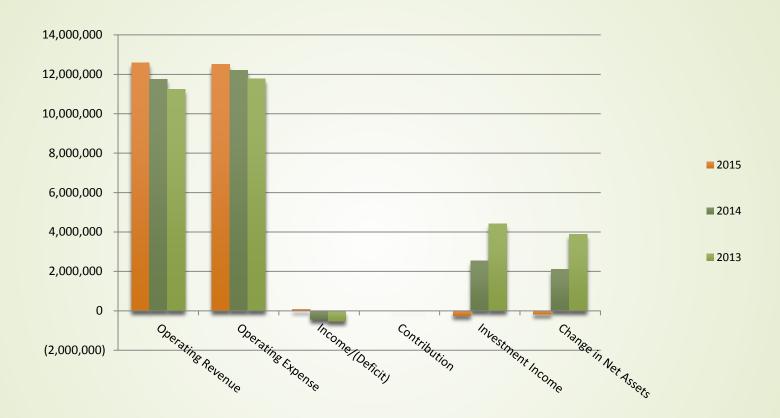
2015 Expenses
